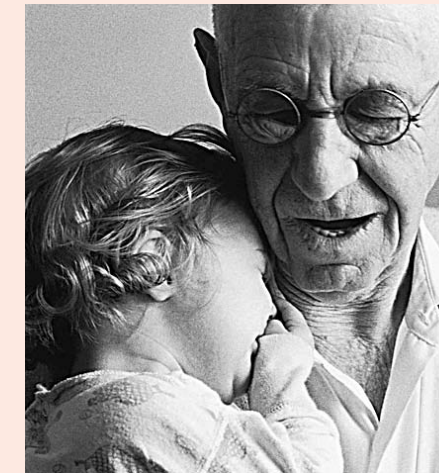

The ultimate impact of these programs is to enhance the capacity of the voluntary sector in order to support its role in making Windsor and Essex County a healthy and vibrant community.

## Creating Culturally Accessible Organizations

Windsor and Essex County are home to more than 103 ethno-cultural groups. Members of ethno-cultural groups experience difficulty accessing services, participating in the leadership of not-for-profit organizations and also accessing meaningful employment opportunities because of systemic barriers present in many social service organizations. In partnership with the Multicultural Council of Windsor and Essex County,

United Way has undertaken a project to assist social service organizations in Windsor and Essex County to identify and remove barriers and to increase the cultural competency of organizations.

This project will assist organizations in increasing their cultural competency practices in the following areas: governance, human resources management, service delivery and partnerships.

The ultimate impact of the project is to provide social service organizations with the knowledge and tools to ensure that they meet the needs of the whole community.

As a leader in the not-for-profit sector, United Way will participate in the change process and will set an example for the other social service organizations in our community.

Windsor and Essex County is the kind of caring community that helps one in three people each year. The people in our community step up to do their part year after year and 2006 was no exception.

We were fortunate in to have Dave Crosswell, CAW Local 200 Financial Secretary, as our Campaign Cabinet Chair and Peter Hrstovec (Raphael Partners, LLP) and Denise Hrstovec (Collins Barrow, LLP) as our honorary co-chairs for the 2006 United Way community campaign. Dave, Peter and Denise care deeply about the community and enthusiastically embraced their roles this year. Here are some of the 2006 campaign highlights:

- 26,671 people got involved by donating financially to the campaign
- 624 workplaces ran campaigns
- Volunteers representing 31 agencies made 70 presentations regarding the impact United Way has in the community
- Seven employees participated as Loaned Representatives. Loaned Representatives are employees who are "on loan" from their organization to United Way during the

annual campaign.

Our campaign goal in 2006 was \$ 8.3 million. This was the amount of money needed by member agencies and the United Way to continue offering the same level of programs and services so desperately needed by our community. We knew that given the state of our economy this was an ambitious goal but one we needed to work toward. Despite the hard work of the campaign team, both staff and volunteers, we did not reach our goal. The amount raised was \$ 7.3 million, a very impressive number to be sure.

Unfortunately, United Way was forced to reduce funding to member agencies and use our best efforts to maximize the impact of the dollars we have. Member agencies' tasks will be especially difficult given that demand for their services is growing. All of these agencies do wonderful work and continue to be one of the main reasons that Windsor and Essex County are known as such a caring community.

A special thank you to all of our donors in 2006, and our sincere hope that you will be able to find it in your heart to be there for the community again in 2007.
