Tax Savings and Donating to United Way

While tax incentives are not the only reason to give to the United Way, they are an important consideration. Federal and provincial tax credits make it easier to donate to the United Way.

United Way donors have a shared vision of a strong and healthy community. By investing in the United Way you can address immediate needs and create long-term impact for one in three of the people living in your community.

As the table below demonstrates, the real cost to you of investing \$100 in your community through United Way is only \$78.95 — a tax savings of \$21.05.

When you consider the same \$100 donation through payroll deduction or pre-authorized payments from your bank account or credit card, the real cost to you of a \$100 investment is only \$3.04 every two weeks.

When you donate more than \$200 per year to United Way your tax savings increase significantly. As the table below demonstrates, the real cost to you of investing \$300 in your community through United Way is only \$217.74 — a tax savings of \$82.26.

When you consider the same \$300 donation through payroll deduction or pre-authorized payments from your bank account or credit card, the real cost to you of a \$300 investment is only \$8.37 every two weeks.

These tax savings can be applied to your income tax payable or your spouse's income tax payable.
