



DINNER FOR TWO ANYWHERE IN THE WORLD RAFFLE SEPTEMBER 2024 TO FEBRUARY 2025

RAFFLE RULES (THE “RAFFLE RULES”)

1. DESCRIPTION OF DRAW

United Way/Centraide Windsor-Essex County, doing business as **United Way/Centraide Windsor-Essex Chatham-Kent (“UWWECK” / “United Way”)**, will administer a Dinner Anywhere in the World Raffle (“**Raffle**”) for the purpose of fundraising toward our fundraising investments. This raffle is a stub draw for **four** prizes:

1. Dinner for Two Anywhere in the World (“grand prize”)
2. Dinner for Two Anywhere in North America (“bonus prize”)
3. Private J.P. Wisner’s Whisky Tasting at Hiram Walker & Sons Ltd for 20 people with the Master Blender
4. Caesars Windsor prize package comprising; a pair of tickets for a show at The Colosseum and a Caesars Windsor gift card for \$200

The prizes are referenced on the ticket. Tickets will be available for purchase from Sunday, September 1, 2024, until 11:45 am Friday, February 21, 2025.

2. HOW TO ENTER

Upon purchasing a ticket/s, the purchaser shall retain the paper ticket portion and the stub portion shall be placed into the ballot drum located at United Way offices, by a United Way staff/representative. All stubs must be received by 11:45 pm on Friday, February 21, 2025, for the 12:30pm Draw Time at the location of the draw. The draw will take place at the United Way offices, located at 300 Giles Blvd. East, Unit A1, Windsor, ON, N9A 4C4.

In order to participate in this draw, a person must not be otherwise excluded from the Raffle pursuant to the restrictions described in Section 7 of the Rules of Draw herein. Entrants must present acceptable identification upon request (see Section 7 herein).

UWWECK takes no responsibility for lost, delayed, stolen, destroyed or misdirected tickets.

3. PRIZE DRAW DATE

The Draw shall be held on **Friday, February 21, 2025, at 12:30 p.m. ET (“Draw Time”)**, at United Way offices, located at 300 Giles Blvd. East, Unit A1, Windsor, ON, N9A 4C4 (“**Draw Site**”).

A United Way Volunteer Representatives will randomly draw four (**4**) **stubs** from the ballot drum, located at the Draw Site. The prizes shall be drawn in reverse order (see section 8.2). The selected entrant need not be present to win.

The winners of the prizes shall be determined by reference to the Name, Address and Telephone Number on the stub/s drawn. The selected entrant will be announced at the Draw Site, called if telephone number is available and will then be publicized on the United Way web site and on all social media sites/pages/accounts administered by UWWECK.

A News Release shall be sent out and the coverage received via this media release shall also reflect further announcements of the selected entrants. Selected entrants will also be publicised on United Way social media channels. (See Section 8.3 herein regarding Privacy/Use of Personal Information.) If the selected entrant is not present, he/she will be notified by telephone and/or by letter to the number and/or address provided on the ticket stub.

4. PRIZES

Prize/s shall be accepted as awarded on the draw date. No cash option will be offered for any of the prizes. Prizes are not transferrable and shall be accepted or declined by selected entrant. Prizes are limited solely to those items explicitly set forth herein and any and all other expenses not provided for shall be the sole responsibility of the selected entrant. Substitution or modifications of the prize shall not be permitted. The decision of UWWECK shall be final on all matters concerning the raffle (subject to approval by the City of Windsor as licensor). All prizes must be claimed within six (6) months of the draw date, namely, August 21, 2025.

The following prizes will be available to be won (collectively the “**Prizes**” and individually the “**Prize**”):

4.1 Grand Prize: *Dinner for Two Anywhere in the World, worth a total maximum value of \$11,000.00 CDN, which includes:*

One trip, including round trip airfare for two (class of service to be determined based on cost/availability/within total Prize value) originating from an airport in Ontario (the “Originating City”) depending on availability to a major airport of a domestic or international city of the winner’s choice (the “Destination City”); hotel accommodations for a minimum of two nights and maximum of seven nights, at a hotel of the winner’s choice. Total value of air travel and accommodations must not exceed \$10,000.00 CDN, including all applicable taxes. All travel arrangements must be made through Valente Travel, who has partially sponsored this prize. Also included is \$1,000.00 CDN (cheque) to cover the cost of dinner for two at a restaurant of their choice in the Destination City as well as any ground transportation and incidentals. The total value for the Grand Prize shall be a maximum of \$11,000.00 CDN.

Grand Prize shall be subject to the following:

- a. To comply with AGCO regulations, the outbound flight must depart from an airport within Ontario and the returning flight must terminate at an airport within Ontario.
- b. Should the winner choose to upgrade to a higher class of travel service, stay longer, add any other passengers, etc., any and all additional expenses (beyond the allowable \$10,000 maximum), shall be their sole responsibility
- c. There are no “black-out” periods; travel dates shall be chosen strictly based on availability of flights and keeping charges within allowable amount

- e. Valente Travel must receive no less than a one month notice prior to the travel dates and be provided with the top three date preferences
- f. Travel must be completed within 18 months of the draw date, namely August 21, 2026
- g. Once airline and/or hotel reservations have been made, the winner is responsible for further charges associated with any changes or for any cancellation penalties, according to the terms of the travel arrangements and/or airline/hotel/insurance purchased.
- h. Should the air travel and accommodations total less than the allowable total value of \$10,000.00, the winner is not entitled to the difference between the stated and actual value, and no cash shall be rendered for this difference
- i. The winner and his/her traveling companion must comply with any customs, immigration and health requirements and must possess all required travel documentation prior to departure, including but not limited to passports and visas if applicable
- j. The flight is governed by the applicable by-laws, regulations and international conventions, as well as the terms and conditions of the selected airline, other restrictions may apply.

4.2 Bonus Prize: *Dinner for Two Anywhere in North America, worth a total maximum value of \$6,000.00 CDN, which includes:*

One trip, including round trip airfare for two (class of service to be determined based on cost/availability/within total Prize value) originating from an airport in Ontario (the "Originating City") depending on availability to a major airport of a domestic or international city of the winner's choice in North America (the "Destination City"); hotel accommodations for a minimum of two nights and maximum of seven nights, at a hotel of the winner's choice. Total value of air travel and accommodations must not exceed \$5,000.00 CDN, including all applicable taxes. All travel arrangements must be made through Valente Travel, who has partially sponsored this prize. Also included is \$1,000.00 CDN (cheque) to cover the cost of dinner for two at a restaurant of their choice in the Destination City as well as any ground transportation and incidentals. The total value for the Grand Prize shall be a maximum of \$6,000.00 CDN.

Bonus Prize shall be subject to the following:

- h. Should the air travel and accommodations total less than the allowable total value of \$5,000.00, the winner is not entitled to the difference between the stated and actual value, and no cash shall be rendered for this difference

4.3 Third Prize: J. P. Wiser’s Whisky Tasting at Hiram Walker & Sons Ltd.” For 20. This package includes Appetizers; five (5) tastings of J. P. Wiser’s products; a presentation by Master Blender, Don Livermore; a personalized gift bottle of J.P. Wiser’s Whisky; and (2) JP Wiser’s glasses for each guest. The value of this special package is approximately \$2,000 CDN.

Third Prize shall be subject to the following:

- a. Must be nineteen (19) years of age or over to qualify for this prize and/or participate in the sampling of Wiser’s products
- b. Booking of this session shall be on weekdays only, between 6:00pm to 8:00pm. date subject to availability.
- c. This package is valid until April 30, 2025
- d. Arrangements for this tasting must be made at least two weeks prior to the date thereof, allowing Hiram Walker staff to make necessary arrangements.
- e. All Arrangements shall be made directly with Hiram Walker staff by contacting the J.P. Wiser’s Experience Center Team: *BrandCenterEvents@pernod-ricard.com*
- f. The tasting will be done in accordance with a “proper” whisky tasting
- g. Hiram Walker reserves the right to exclude any attending member during the event (having applied Smart Serve principles) for the safety of both HWSL employees and assets and those of the attending group
- h. This prize is not transferrable and must be accepted by selected entrant.

4.4 Forth Prize: Caesars Windsor Prize Package comprising; a pair of tickets to an upcoming performance in The Colosseum at Caesars Windsor, and Caesars Windsor Gift Card (\$200 CDN), The value of this package is \$400 CDN.

Forth Prize shall be subject to the following:

- a. All elements of this package have no cash value, are non-transferable, non-replaceable, and cannot be amended.
- b. Caesars Windsor is not responsible for lost or stolen tickets.
- c. Recipients and participants must be 19 years of age or older.

- d. Promotional Gift Cards are redeemable only at Caesars Windsor outlets. They are not accepted at third-party outlets (Johnny Rockets, Spago, Tim Horton's, Landau), cannot be redeemed for cash, and must not be used for gratuities. They cannot be used on Fireworks or New Year's Eve, nor to purchase gift cards.
- e. Guests must be 19 years of age or older to attend concerts, enter the casino, and access all other outlets.
- f. Tickets must be requested for shows past February 2025, and show must occur during the year 2025.
- g. Show choice is subject to availability, level of artist, and management discretion.

5. TICKET PRICE AND NUMBER OF TICKETS

Ticket price is \$10.00 CDN each or 3 Tickets for \$25.00 CDN. The maximum number of tickets available for sale will be 9,700. Tickets will be sold in advance of the draw. There is no limit on the number of tickets able to be purchased by any one individual.

6. TICKET SALES

Tickets will be available for purchase, between September 1, 2024, and February 21, 2025, in the following ways:

- 6.1 In person at UWWECK offices, located at 300 Giles Blvd. E., Unit A1 in person, between the hours of 8:30am and 4:30pm Monday through Friday, except statutory holidays, where they can pay for their ticket purchase via cash, cheque, debit or credit card
- 6.2 Via UWWECK web site www.weareunited.com/raffle where a purchaser can click on the link for Dinner Anywhere in the World Raffle ticket sales and purchase the desired number of tickets (no limit). Payment will be completed via debit or credit card electronically.
Once online purchase has been processed, UWWECK will email or mail out the appropriate number of ticket stubs by mail to the purchaser's mailing information provided.
- 6.3 By calling UWWECK offices at (519) 258-0000 to order desired number of tickets and complete the payment process via credit card over the telephone. Once the order has been completed, ticket stubs will be mailed or emailed to the purchaser's mailing address provided
- 6.4 In person from selected United Way representatives at certain workplaces and events. Cash, and/or debit card and credit card options may be available depending on time and location.

7 PRIZE CLAIM

To claim a Prize, the selected entrant must attend, in person, at the offices of United Way Centraide Windsor-Essex, 300 Giles Blvd. E., Windsor, ON no later than **August 21, 2025** (the "**Prize Claim Deadline**") at 4:30 p.m. ET. Prize claims will take place only during business hours of 8:30 a.m. ET to 4:30 p.m. ET Monday to Friday.

In order to claim a Prize, the selected entrant will be required to present valid, government issued, photo ID and sign a standard declaration and release form, confirming: (1) compliance with the Raffle rules; (2) acceptance of the Prize/s as awarded; and (3) release of UWWECK and the Prize sponsors (the “**Sponsors**”) and each of their employees, directors, officers, suppliers, agents, sponsors, administrators licensees, affiliates, representatives, advertising media buying and promotional agencies (the “**Releasees**”) from any and all loss, harm, liability, damage and expense arising out of acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom. **Failure to comply will result in forfeiture of the Prize/s.** Once this requirement has been fulfilled, the selected entrant shall then be declared the “winner”. Failure to sign and return said documents in a timely fashion (within 24 hours upon receipt of the release) or if Prize/s is/are returned non-deliverable, may result in Prize forfeiture.

8 RULES OF DRAW

8.1 Eligibility.

- 8.1.1** To be eligible for this Raffle or any Prize, an individual must be of 19 years of age or older.
- 8.1.2** UWWECK staff, Board members and immediate families of staff and Board members residing in the same household are not eligible to participate in this Raffle or to win any Prize. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household. UWWECK volunteers, friends and family (not residing in the same household), are eligible to participate in the raffle and win the Prize/s.
- 8.1.3** Cheque or money order used for the purchase of the ticket/s must be made payable to United Way/Centraide Windsor-Essex Chatham Kent. If an entrant’s cheque is dishonoured by the bank, or payment by credit/debit card is dishonoured by the card merchant, the entry will be declared invalid unless full payment is received and cleared, prior to the draw.

8.2 Winner Selection.

- a. The Prizes will be drawn in the following order: (1) Fourth Prize; (2) Third Prize; (3) Bonus Prize (4) Grand Prize. Winning stubs for the Fourth, Third and Bonus prizes shall each be re-entered so they are eligible for subsequent prizes, including the Grand Prize.
- b. UWWECK shall be responsible for awarding the Prize and making all reasonable efforts to contact the selected entrants.
- c. The paper stubs from the draw drum and unsold tickets shall be secured or placed in safekeeping for a period of six (6) months following the draw date, namely August 21, 2025.
- d. Prizes shall be accepted by selected entrant and in the process outlined herein. Once declared the “winner”, he/she **may not transfer any or all of the Prize/s won** and prizes shall not be used for the purpose of further raffling off or selling for profit.
- e. Should a selected entrant not accept a prize within six (6) months of the draw date, namely **August 21, 2025**, the prize or monies equivalent to the fair market value of the prize will be donated to a beneficiary approved by The Corporation of the City Windsor, as the licencing authority.

- f. UWWECK shall have the right at any time to require proof of identity and/or eligibility to participate in the Raffle. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the UWWECK for the purpose of the Raffle must be truthful, complete, accurate and in no way misleading. UWWECK reserves the right, in their sole discretion; to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.
- g. The odds of being selected depend on the total number of eligible entries accumulated for the draws.
- h. The paper stubs from the draw drum shall become the sole property of UWWECK and will not be returned.

8.3 Privacy/ Use of Personal Information.

- a. The personal information collected in the course of the Raffle will be used for the purposes of identifying selected Prize entrants and administering the Prizes.
- b. By accepting the Prize, the winner agrees to the use of his/her name, address, photograph, videotape, voice, signature and any likeness for advertising or publicity purposes and to the use of statement made by or attributed to the winner, provided same are true, relating to the UWWECK, and any and all rights to said use without further compensation, except where prohibited by law.

8.4 Indemnification by Entrant. By entering the Raffle, entrant releases and holds the Releasees (as defined in Section 7) harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, disappointment or inconvenience resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any Prize, participation in the Raffle, any breach of the Raffle Rules, or in any Prize-related activity. The entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Raffle, without limitation.

8.5 Extent of Liability. UWWECK is solely responsible for the conduct of the draw. By participating in this Raffle, entrants agree that:

- a. The Sponsors of the Prizes are not responsible for any incorrect or inaccurate information associated with or utilized in the Raffle or by any technical or human error which may occur in the administration of the Raffle.
- b. All Prize claim information is subject to verification and will be void if not obtained through legitimate channels, or if not original, or if illegible, altered, forged, garbled, defaced, mutilated, mechanically or electronically reproduced or tampered with in any way, or if the ticket/s contain/s printing or production errors or if not obtained in accordance with these Rules.
- c. If the Raffle is interfered with, or it is impractical to conduct or continue to conduct, in whole or in part, as a result of fire, explosion, power failure, acts of God, civil commotion and/or labour unrest, including but not limited to strikes, slow-downs, lock-outs, picketing or boycotts and/or conditions/restrictions imposed by governments or public health authorities, UWWECK and their respective officers, directors and employees shall be released from any and all responsibility and/or liability arising from such interference or impracticability. UWWECK will then follow instruction of The Corporation of the City of Windsor who are the licencing authority for this raffle.

- 8.6 **Conduct.** By entering this Raffle, entrants agree to be bound by the Raffle Rules and decisions of UWWECK or the Sponsors, which decisions shall be final and binding in all matters related to this Raffle. The UWWECK reserves the right to declare any entry void and award the Prize to the next drawn entrant if a selected entrant is found to be: (a) violating the Raffle Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Raffle; and/or (c) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE THE LEGITIMATE OPERATION OF THE RAFFLE MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, UWWECK RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING BUT NOT LIMITED TO CRIMINAL PROSECUTION.
- 8.7 **Law.**
- a. This Raffle is subject to all federal, provincial and municipal laws of Canada. All issues and questions concerning the construction, validity, interpretation and enforceability of the Raffle Rules or the rights and obligations as between the entrant and the UWWECK in connection with the Raffle shall be governed by and construed in accordance with the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
 - b. All times stated are local Windsor, Ontario times and all values stated are in Canadian Dollars.
 - c. This Raffle is being held pursuant to a lottery licence issued by the Corporation of the City of Windsor, in accordance with their requirements. A copy of the licence may be obtained by calling the UWWECK office.
- 8.8 **Intellectual Property.** All intellectual property, including but not limited to trade-marks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans and representations are owned by the UWWECK, the Sponsors and/or their affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
- 8.9 **Language Discrepancy.** In the event of any discrepancy or inconsistency between the terms and conditions of the Raffle Rules and disclosures or other statements contained in any Raffle-related materials, including but not limited to the ticket, or television, print or online advertising, the terms and conditions of the Raffle Rules shall prevail, govern and control.
- 8.10 **Administration of Raffle.** This Raffle is administered by United Way/Centraide Windsor-Essex County, 300 Giles Blvd. E., Windsor, Ontario N9A 4C4.
